## **Updates:**

Michelle N. is collaborating with a team on legislation to mandate radon testing in schools and radon-resistant construction in new buildings. If passed, this would impact all 500+ PA school districts, with an estimated 40% of buildings requiring mitigation by certified professionals.

Ned shared a recent study linking fracking to childhood cancer: Exposures from Oil and Gas Development and Childhood Leukemia Risk in Colorado: A Population-Based Case—Control Study | Cancer Epidemiology, Biomarkers & Prevention | American Association for Cancer Research

CENSWPA is partnering with the University of Pittsburgh for their second Environmental Justice Summit, based on outcomes from the previous year. The 2025 series includes five events (three in-person, two virtual): 2025 Environmental Science, Justice, and Healing Series Registration
