Kayla Knock - PAIC is placing local ads in newspapers to encourage 18-45yo to get vaccinated. Interested in quarter page ads across rural Pennsylvania. Also exploring billboards, bus campaigns, radio ads, local newsletters, ads on paper placemats at local eateries, etc. as part of their media campaign.

Kacie Jankoski (ACS - Western PA taskforce). Videomessaging including local physicians and survivors. Seeking help with messaging (theme, tone, etc.). Conducting focus groups to get an idea of what messaging will be most impactful. Dr. Mana Mozaffarian – suggested considering some wording around oral cancers as they impact functions of eating, swallowing and features with visual impact to face, survivor stories, extent of treatment and visual changes. William Calo – used narrative persuasion theory to guide development of messaging https://sites.psu.edu/impscilab/resources/ Suggested to create a social media truncated version (30-60seconds) and add a link to a full length video (5min) for those who are interested. Dr. Mana Mozaffarian – audio ads during podcasts are more likely to be clicked than ads with videos. Heather Entenmann – cervivor is a cervical cancer survivor organization and build out ambassadors and champions for survivor to connect with the community. https://cervivor.org May be good reference as well and potential survivors in Pittsburgh or other PA areas

William Calo – HPV ECHO launched successfully 8/10 with 13 clinicians joining the first session! Interest in coadministration of HPV vaccine with COVID-19 vaccine. Sessions will focus on how to discuss coadministration with parents. Training is funded by NCI to train primary healthcare teams how to communicate with parents. Dr. Mana Mozaffarian – encouraged them to include dentists and pharmacists that they can be included in training. Nicole Parkerson – encourage vaccination at 9 to separate vaccines and have less coadministration issues vaccines. Erin Moskel – willing to help encourage participants to stay engaged in study as she has partners participating in the ECHO. She will reach out to Chelsea to confirm any of her partners who may be on participant list (offline conversation)
