- FQHCs serve more than 912,000 people annually across 350 sites
- Hosted webinar series to address vaccine hesitancy topics included: sociological, medical and geographical, determinants and partnerships, and health literacy
- Keystone Health developed a series of videos that are 20-30sec in length and are played in their waiting rooms



- 6. Old Business by Pam Schauer -
- 2024 Multi-state HPV awareness Campaign Call to Action
  - States involved: MD, WV, VA, DC, DE, PA
  - Dr. Torres Del Valles from DOH/Bureau of Immunization (BOI) is working to get Dr. Brogen's signature with the goal to send letter by March 4th
  - William Calo is reviewing letter to provide feedback
  - Pam Schauer call for assistance for disseminating the letter
    - Candace VFC (1500 providers) and WIC organization
    - Jennifer adolescent immunization coordinator can share with their lists
    - Srijana BOI Adult coordinator can share with her list
    - William Calo all health systems can distribute within their clinics.
    - Susan Radio I'd be happy to share within our UPMC Hillman Cancer Center distributions and school systems that we are a part of.
    - Pam will ask for metrics to show providers reached
    - Brenda received notice that PAFP will also distribute for us and they have 5,000 members
- Hep B Vaccination Updates
  - All adults receive testing at <u>least once</u>
  - Brenda there is funding for this with the Governor's proposed budget; health equity call re: the REACH grant to discuss harm reduction activity focusing on women's groups. David Saunders can pull names of groups working on these activities to share information on HPV with these groups
  - Lauren Orkis is interested in learning more about the REACH grant. Through SAMSHA are trying to increase Hep A and B vaxes given in drug and alcohol facilities. Goal to purchase vaccines to distribute
- 7. <u>New Business & Resource Sharing</u> by Pam Schauer –
- The American Cancer Society (ACS) and The National HPV Vaccination Roundtable (HPVRT) are seeking rural healthcare partners to join a learning community focused on improving HPV vaccination among 9–12-year-olds.
- Through a series of virtual sessions and peer-based learning, the rural disparities HPV vaccination learning community will use quality improvement (QI) and evidence-based interventions to increase vaccine rates. This no-cost, practical how-to learning community will serve as a forum for health partners to gain knowledge, exchange promising practices, and talk through challenges to increasing HPV vaccinations in rural settings.
- In celebration of the seventh annual International HPV Awareness Day on March 4, 2024, the St. Jude HPV Cancer Prevention Program is hosting a series of five virtual seminars that will focus on HPV vaccination priorities in the Southeast, rural communities, and school-based settings; the future of cervical cancer elimination across the globe; and challenges associated with HPV vaccination in childhood cancer survivors. William Calo will be a speaker for these on February 28<sup>th</sup>!
