6. New Business & Resource Sharing by William Calo —

Will be sharing it with the workgroup soon! Will be available on social media platforms (Instagram, Facebook YouTube).

7. Open Member Sharing & Any Action Steps – by Pam Schauer Brenda Anastasio – The March PCC meeting was cancelled.

Uzoma Iheagwara – New Member--Radiation Oncologist at UPMC horizon, willing to be a RadOnc consult as needed for the team. Regularly consults on HPV-positive cases.

Mana Mozaffarian – From Middle East had first hand experience with the culture disconnect between understanding what the vaccine protects against and being stuck on the vaccine being a "sex vaccine." Her mother was against her receiving the HepB vaccine at 16 once it was referenced that it protects againt an STD related cancer. It's important to keep this conversation in mind and the implications of referencing STIs, when recommending vaccination to patients/parents.

Madalyn Schaefgen – has done webinars re: HPV vaccine hesitancy and will try to share these with the Workgroup!
