Brenda – Draft of the 2023 Cancer Control Plan has been submitted to DOH communications. She quickly scrolled through the report to give a preview to the attendees. They were able to incorporate almost of the coalitions feedback. Going through communications and legal review, then DGS. Brenda will share final report when it's ready

- William Calo provided some feedback to the report when reviewing the presented measures. HPV vax focused on increasing vaccination, while Hep B focused on decreasing cancer rates.
 - Brenda's response There isn't great data for vaccination rates of Hep B. Liver cancer prevention made sense to list as a measure because there are so many other variables and a lack of reliable data.
- William Calo for prevention strategies instead of focusing on Hep B and HPV separately and a combined maybe just include the combined. Made note on women up to 45 years of age – Brenda will make edit was meant to be specific to cervical cancer screening.
- William said he is willing to review more in-depth and provide feedback.

Brenda – Tracy Ray has been updating online membership form (population served, geographic area, etc.). This will go live in two weeks and there will be a push for all members to update that profile online.
