Dental/HPV Module & HPV Dental Toolkit for Offices----The course has been live for about 2 weeks. Report out on usage numbers will be coming. The course is approved for dental CEUs (1.0 hour) through the Academy of Dental Hygiene Studies (a board credit sponsor for CE in PA), which is a PA state board of dentistry-approved provider. PA Oral Health Coalition has distributed our HPV toolkits to more than 300 dental providers across the state as well. They will have pre- and post-survey results in the late fall on their use. - Gap between rural and urban still persists
- Brenda Anastasio will provide the 2020 and 2021 VFC data to compare to the NIS-Teen data
- Response rate is 21% which is similar to prior years
- 41% of participants have provider validated data this is a decrease from the past NIS-Teen report that had 48%
- How are less vaccines being ordered, yet an increase in vaccination rates? There seems to be a discrepancy in the data

Michael Goldstein – VFC (CDC orders in PA). In Philadelphia order are up about 1%, but Pennsylvania as a whole is down 15%. 4100 doses year to date vs. previous year
