4. Welcome by William Calo --

5. Old Business by William Calo —

- Review Cancer Plan, specifically objective 2.2 strategies for increasing HPV vaccination rates https://www.pacancercoalition.org/about-us/pa-cancer-control-plan
 - William talked through strategies with a focus on the up to 26 age range
 - Luke Cunniff shared about how we can better engage college students to get them vaccinated
 - Madalyn Schaefgen need to better involve family medicine to target this age range
 - William Calo agrees with Dr. Schaefgen that there isn't a focus on how to recommend vaccination for these later ages
 - Luke The Indiana IZ Coalition just put together a college HPV toolkit: https://projecthpvfree.org/

- Mana Mozaffarian College health centers might be great partners for the last 4 bullets (ex., integrating HepB with HPV vaccine for the "missed kids" because of parental controls)
- William focused on the 27-45 age group
 - Katie Noss shared that there are concerns re: uninsured or underinsured for getting this as an adult. There isn't a VFC equivalent for adults
 - Brenda Anastasio
 — when doing breast and early detection, they do HPV cervical testing
 and can target this age range with that work for HPV vaccination. Maybe include
 Men's Health Workgroup to reach men as well.
 - Luke Cunniff In the 27-45 cohort, some of the larger hospital networks in the region are kicking off initiatives to educate their own employees on HPV vaccination and offering it on site for them. Dana Farber in MA is one example that comes to mind
 - Katie Noss <u>NCIRD Immunizations (cdc.gov)</u> are we able to push this forward? Can policy workgroup help push this forward?
 - Brenda DOH employees are restricted, but the Workgroup is not and can absolutely push this forward. Can be a subgroup or a whole group. DOH can still supply data. Ruth is contact for policy group.
 - Interested in support this: Katie Noss will supply additional members from her team, Madalyn Schaefgen, Manna Mozaffarian, Luke Cunniff
 - o Brenda suggested ACS CAN could maybe help with this.
- RE: Standing orders and recall notices
 - William Calo shared how his team is preparing a new grant application to really focus on these system communication approaches. Opens the floor to anyone doing a good job with these.
 - Katie Noss a pharmaceutical company provided templated postcards for parents.
- Brenda shared that they are working on disseminating the cancer plan through the work groups.
- William summed the report and the workgroup's focus for the next 10 years
- Brenda encouraged workgroup members to pull slides from DOH site and encouraged people to adapt the slides and present them. When presented, members were asked to please keep a simple list of who they have distributed the Cancer Plan to (type of organization, method of distribution (email, print, web posting)- share back with Pam to send to Brenda A. and the team. Also, members are encouraged to provide feedback on the plan, it's an adaptable plan, not intended to be stagnant for 10 years. Plan to do an evaluation and potential revision to the document every 2 years to adjust measures and metrics as appropriate.
