5. **Old Business** –Vaccine for Adults (VFA) 317 Funding

(Called 317 Funding)

Desiree Weisser – The goal is equitable distribution of vaccines across the state – enrollment is growing but funding is static (this problem needs to be addressed through legislation). The success of Bridges Access Program (~170 providers across the state) could support a more permanent program in the state. Training sessions for providers are in-person and virtual beginning in November 2023 (will be sending that information to Pam). State funding has never been extended to vaccination – only federal funding, but a bill is currently in the pipeline to acquire state funding. New immunization documentation system going live on February 17th.

Srijana Parajuli – Vaccine fatigue among federal organizations. Had challenges recruiting providers for bridge action. Trouble getting patients in for any vaccinations.

Daniel Serrano – Having difficulties getting the vaccines, but patients need to be vaccinated so having to use private stock of the clinic.
