5. Member Spotlight by William Calo –

- a. William has announced that he is stepping down as co-chair of the workgroup and said it would be great to have a co-chair that can represent the HBV side of the workgroup
- b. William's team is conducting a RCT funded through the NCI as an R21 to test a video intervention with 200 parents to determine if it influences vaccine decision making regarding HPV vaccination. RCT is comparing a cancer survivor story compared to a control video on healthy eating. William shared a video from Wendy an HPV cancer survivor and Hillary a nutritionist at PSH. Hillary is able to go to events and provide nutrition education.
