## • Workplan for 2024-2025 Updates:

Goal 1:Expand the promotion of lung cancer screening education, activities, resources, and tools to include Health Systems and their Primary Care Physicians, health clinics, Federally Qualified Health Centers (FQHCs), patient navigators, community health workers, and care coordinators from the insurance industry. We will use a health equity lens to identify and then focus efforts on those individuals/groups who are placed at a higher risk and who are experiencing disproportionate effects.

Goal 2:Promote activities, programs, and initiatives to decrease adult and youth tobacco and vaping usage. We will use a health equity lens to identify and then focus efforts on those individuals/groups who are placed at a higher risk and who are experiencing disproportionate effects.

**Goal 3**: Reducing radon exposure through PSE (Policy, Systems, and Environment) changes with a focus on individuals/communities who are placed at a higher risk and who are experiencing disproportionate effects.

- a. Testing for radon in areas with historically high radon levels and historically low testing rates, as well as environmental justice areas.
- b. Installing low-cost or pro-bono mitigation systems.
- c. Assisting communities to locate funding sources for mitigation systems

**Goal 4**: Educating and working with larger professional groups, such as Legislators, Physicians, School Administrators, and Builders, on the health risk associated with radon exposure and smoking.

- d. Increase capacity of providers to assess and discuss environmental risks such as radon exposure with patients through education.
- e. Disseminate data and radon education to identified policy influencers: PA Cancer Caucus, PA House of Representatives and the PA Senate
- f. Engage Women for a Healthy Environment to address schools and daycares across PA.
- g. Engage Tobacco Cessation Providers to incorporate radon information when speaking with clients.

  - i. Distributed radon kits and shared information about radon, saved by the scan, and tobacco cessation

  - ii. HB 259 with Representative Briggs; also mandatory radon testing for schools
  - iii. The bills are not worded exactly the same; slightly different but cover the exact same thing

# g. Tiara Parker – Hillman Cancer Center on Community Outreach and Engagement Team; Patient Navigator

- a. Will be attending a lot of events in the summer
- b. Will be starting their own tobacco cessation program
- c. Just attended an event at the Latino Health Fair on May 17<sup>th</sup>; discussed at their table effects of radon and lung cancer
- d. Will be attending Good Neighbor Day on June 11<sup>th</sup>; will be discussing the effects of radon and lung cancer
- e. Will let her nurse that is a certified tobacco cessation counselor that she should consider incorporating radon information when speaking to clients

# h. Ron Myers – Thomas Jefferson University; Director of Center for Health Decisions and part of the Comprehensive Cancer Center

- a. With Commonwealth of PA Cure Funds; completed and submitted final report on Lung Cancer Screening and Primary Care and the Impact of Patient Outreach in Primary Care Settings to Health Systems
  - i. Identified primary care patients who were potentially eligible for lung cancer screenings through EMR databases in health systems
  - ii. Reached out to those patients and found that 75% of those patients are actually not eligible for lung cancer screenings
    - 1. These patients were not eligible because information on pack years and quit years were inconsistent and inaccurate in the medical record
    - 2. Should consider how to help PCPs identify who is eligible
  - iii. The 25% that were eligible billed to two outcomes:
    - 1. Referral or order for lung cancer screenings
    - 2. Completion rate
  - iv. Their intervention was focused on trying to guide patients through a shared decision-making telephone conversation about lung cancer screenings
    - 1. Found that 65% of those patients actually received a referral for a lung cancer screening
    - 2. Achieved a 45% lung cancer screening rate
  - v. Concluded that patient outreach is quite effective in increasing lung cancer screenings in health systems
  - vi. Discussion: Could eligibility be inclusive of high radon areas?
    - 1. Answer is no for now because insurance does not include this as a billing guideline to cover for Lung Cancer Screenings
- b. Moving into 4<sup>th</sup> year of 5 years of NCI funded study; testing patient outreach in comparison to provider support, and the combination of these two things
  - i. Study is ongoing, but optimistic that the integration of patient outreach and provider support could make a difference in lung cancer screening
- c. National Lung Cancer Round Table is in the process of identifying interventions/materials/methods that can be shared with all states for the November Lung
  - i. Discussion: Has there been talk about encouraging more PA screening facilities to participate in National Lung Cancer Screening Day?
    - 1. Has not been raised previously, but will raise this issue in the next meeting Ron attends.

- d. Discussion: Articles about CT scans and the concern that they may be contributing to more cancer than what was originally thought
  - i. Needs more research for this study and needs to differentiate between low-dose CT scans and CT scans for lung cancer screenings
  - ii. Should eventually be addressed
