- The group had a brief discussion regarding acting Secretary of Health Dr. Debra L. Bogenas well as the pending state budget. From the meeting chat, Donna Greco provided the link indicating that the budget has passed both chambers:

- 2) Attendees introduced themselves; Ruth reviewed the purpose of the group is to support the Cancer plan goals through policy activities and building partnerships.
- 3) In reviewing the Policy Tracking Table updates were made of note:
 - a) Copay Accumulator (SB372)-- Donna Greco updated and indicated that ACS-CAN received a grant from Pfizer to educate regarding the impact of co-pays towards the financial toxicity of receiving cancer care. Social media campaigns are being formulated and Donna will update as things progress.
 - b) PA Biomarker Testing Legislation Coalition: Donna Greco: if you and your organization are interested in being a part of this work, contact Donna (donna.greco@cancer.org). Bi-weekly meetings; a group or individual may participate as they are able. There are co-sponsors in the Senate, and the bill is just about ready to be introduced; Mullens and Cutler submitted a co-sponsorship memo for the House (not yet available online)

- c) PA Preventive Care Act (HB1050): Gary Rathsmill will update us further next month; this appears to be in response to the overturning of some coverage by ACA by a judge in Texas. Donna Greco heard that the Senate was interested in this as well, but that there would be no activity until the fall session.
